# **Interview Agenda**

It is strongly recommended the presentation be led by the members of the Team who will be implementing and managing the work on a daily and ongoing basis throughout the Project.

To allow your presentation to flow uninterrupted, we will endeavor not to ask any questions during your presentation and wait until the Q&A period.

#### 10-15 minutes

CM Firm introduction, highlighting project experience and qualifications as a Firm from a local standpoint\*. Introduce Team members, elaborating on their experience, qualifications, and role on the Project.

\*If your firm is a national or global firm: while we appreciate the broad experience and depth a national or global firm can provide, we are more interested in what the local branch of the firm can provide.

## 45 minutes

Aside from the schematic pre-construction list of deliverables identified and defined in the CM RFQ, what else can your Firm 'bring to the table' during this initial pre-construction phase?

Graphically present Team members' availability and involvement during the (1) schematic preconstruction phase, (2) pre-construction phase (post approval), and (3) construction phases of the Project. While we understand certain team members will be heavily involved in early phases and less involved in other phases (an example is estimating services), we are interested in clearly understanding the continuity of team members from day 1 to the completion of the Project.

Present your Firm's approach to the Project in as much detail as possible.

Although we are interested in your Firm's approach to constructing the two-story, 274,000 +/- new school facility, we are more interested in your approach to logistics and phasing outside the construction area. Areas of interest are

- (1) initial mobilization
- (2) phasing/logistics on-site
- (3) understanding, timing of constructing, and use of entry way to school/library campus
- (4) completing the building project, and associated sitework to provide, as best as possible, a functional bus/student drop off and pick up area/zone
- (5) while the new school facility is operational, show phasing/logistics for abatement and demolition of the existing school building, and other site improvements, including the new fields and pre-k building.

- As with every school project, this Project has a site riddle or puzzle to solve, with a robust amount of utilities. Please elaborate on how you will propose to solve this puzzle of constructing the new school while allowing the existing school to function as you complete the remaining scope of the Project.
- Please provide your approach and management to address the most challenging 5% of a Project, the management and completion of the punch list.
